The Fund is managed by Invesco Management S.A., part of the Invesco Group.

## Objectives and Investment Policy

- The objective of the Fund is to achieve a reasonable level of income, together with capital growth.
- The Fund invests at least 80% of its net asset value in shares of companies in the United Kingdom.
- The Fund is actively managed and is not constrained by a benchmark. The performance of the Fund may be compared to a benchmark, for comparison purposes only, where a suitable comparator exists (please refer to the Past Performance section below where a benchmark will be displayed if relevant).
- You can buy and sell shares in the Fund on any Dealing Day (as defined in the Prospectus).
- Any income from your investment will be reinvested.

- The Share Class is in risk category 5 due to the rises and falls of its price or simulated data in the past.

## Other Risks

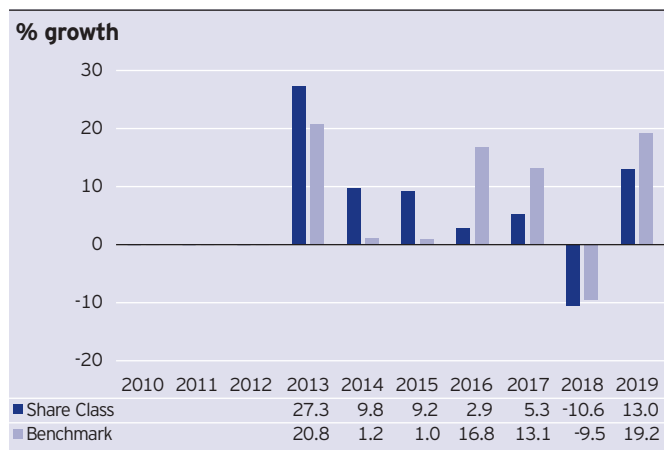
## Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

- Any entry charge shown is a maximum figure. Where charges are shown, in some cases you might pay less; you can find this out from your financial adviser or distributor.
- The ongoing charges figure is based on expenses for the year ending February 2020. This figure may vary from year to year. It excludes portfolio transaction costs except in the case of an entry or exit charge paid by the Fund when buying or selling shares/units in another fund.
- There is currently a discretionary cap on the ongoing charge of 0.91% in place. This discretionary cap may positively impact the performance of the Share Class.
