The Fund is managed by Invesco Management S.A., part of the Invesco Group.

#### Objectives and Investment Policy

- The objective of the Fund is to achieve long-term capital growth, together with income.
- The Fund invests primarily in debt instruments worldwide (including but not limited to debt issued by governments and companies, and convertible bonds including contingent convertibles).
- The Fund may invest in non-investment grade (lower quality) debt instruments, including debt instruments which are in financial distress (distressed securities).
- The Fund may also gain exposure to securitised debt.
- The Fund will make significant use of derivatives (complex instruments) in order to (i) reduce the risk and/or generate additional capital or income and/or (ii) meet the Fund's investment objectives by generating varying amounts of leverage (i.e. where the Fund gains market exposure in excess of the net asset value of the Fund).
- The Fund is actively managed within its objectives and is not constrained by a benchmark.
- You can buy and sell shares in the Fund on any Business Day in Luxembourg (as defined in the Prospectus).
- Any income from your investment will be paid semi-annually.

#### Other Risks

- Investments in debt instruments which are of lower credit quality may result in large fluctuations in the value of the Fund.
- The Fund may invest in contingent convertible bonds which may result in significant risk of capital loss based on certain trigger events.
- The Fund may hold a large amount of Asset Backed Securities (ABS) (complex instruments) as well as lower quality debt securities which may impact the liquidity of the Fund under certain circumstances.
- Return on your investment may be adversely affected by variations in exchange rates.
- It may be difficult for the Fund to buy or sell certain instruments in stressed market conditions. Consequently the price obtained when selling such instruments may be lower than under normal market conditions.

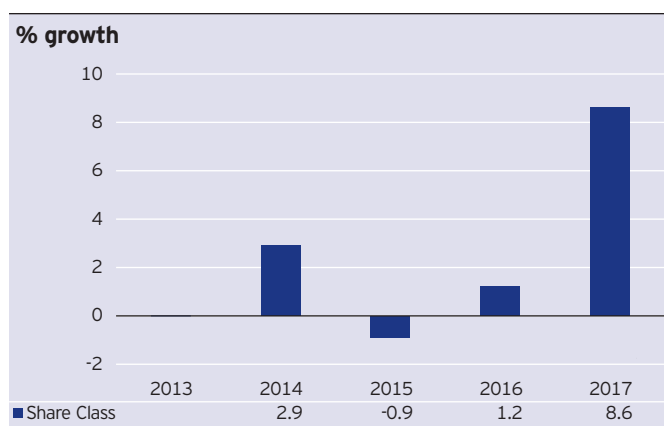
## Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

- Any entry charge shown is a maximum figure. Where charges are shown, in some cases you might pay less; you can find this out from your financial adviser or distributor.
- As the Share Class has been recently launched, the ongoing charges figure is estimated based on expected total of charges. This figure may vary from year to year. It excludes portfolio transaction costs except in the case of an entry or exit charge paid by the Fund when buying or selling shares/units in another fund.
- There is currently a discretionary cap on the ongoing charge of 0.53% in place. This discretionary cap may positively impact the performance of the Share Class.
- If you switch funds, you will pay a maximum switching charge of 1% on your new fund.
