Purpose

What is this product?

The Umbrella Fund is established under the laws of Luxembourg and harmonised under the EU Council Directive 2009/65/EC relating to Undertakings for Collective Investment in Transferable Securities (UCITS).

Term

The Fund does not have a maturity date and may only be terminated in accordance with the terms set out in the Prospectus.

Objectives

- The objective of the Fund is to outperform the MSCI EMU Index (Net Total Return) in the long term and to support the transition to a low carbon economy over the medium to long term.

- The Fund will be invested in shares of Eurozone companies that, in the view of the Investment Manager, demonstrate the ability and willingness to reduce their carbon emissions at a greater rate than the benchmark, MSCI EMU Index (Net Total Return).

- The Fund will employ screening to exclude companies that do not meet the Fund's ESG criteria including (but not limited to) the level of involvement in certain environmental issues such as coal extraction and production, involvement in unconventional oil and gas as well as non-climate-related sectors such as tobacco.

- The Fund is actively managed and is not constrained by its benchmark, the MSCI EMU Index (Net Total Return), which is used for comparison purposes. However, the majority of the Fund's holdings are likely to be components of the benchmark. As an actively managed fund, this overlap will change and this statement may be updated from time to time.

- The Fund has broad discretion over portfolio construction and therefore securities, weightings and risk characteristics will differ. As a result, it is expected that over time the risk return characteristics of the Fund may diverge materially to the benchmark.

- The Fund promotes environmental, social and governance (ESG) criteria as covered under Article 8 of the Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector.

The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Performance Scenarios

What happens if IMSA is unable to pay out?

The assets of the Fund are segregated from those of IMSA. The Depositary is responsible for the safekeeping of the assets of the Fund. To that effect, if IMSA defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk for the Fund suffering some loss in case of default of the Depositary. As a shareholder in the Fund, there is no compensation or guarantee scheme in place.
