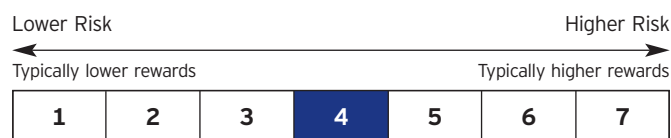
The Fund is managed by Invesco Management S.A., part of the Invesco Group.

Objectives and Investment Policy

- The Fund is a feeder fund of Invesco Perpetual Income Fund¹, a sub-fund of Invesco Perpetual UK 2 Investment Series¹ incorporated in England and Wales (the "Master").
- The objective of the Fund is to achieve a reasonable level of income, together with capital growth by investing at least 85% of its assets in the Master which invests primarily in shares of companies in the United Kingdom but may include some international and unlisted investments. The Fund may also hold cash and cash equivalents up to 15% of its net assets.
- However, the Fund intends to be normally fully invested in the Master.
- The Fund will not use derivatives.
- The Master may use derivatives (complex instruments) to manage the fund more efficiently, with the aim of reducing risk, minimising costs or generating additional capital or income.
- The Fund is actively managed within its objectives and is not constrained by a benchmark.
- You can buy and sell shares in the Fund on any Business Day in Luxembourg (as defined in the Prospectus).
- Any income from your investment will be reinvested.

¹Effective 1 October 2018 Invesco Perpetual Income Fund was renamed Invesco Income Fund (UK) and Invesco Perpetual UK 2 Investment Series was renamed Invesco UK 2 Investment Series.

Risk and Reward Profile



- The Share Class is in risk category 4 due to the rises and falls of its price or simulated data in the past.
- As the Share Class' risk category has been calculated using historical data, it may not be a reliable indication of the Share Class' future risk profile.
- The risk category may change in the future and is not guaranteed.
- The lowest category does not mean a risk free investment.

Other Risks

- The value of investments, and income from them, can go down as well as up and you may not get back the full amount you invested.
- Shares of companies are generally considered high risk investments and may result in fluctuations in the value of the Fund due to external factors.
- As one of the key objectives of the Master is to provide income, the ongoing charge is taken from capital rather than income. This can erode capital and reduce the potential for capital growth.
- The Master may use derivatives (complex instruments) in an attempt to reduce the overall risk of its investments or reduce the costs of investing, although this may not be achieved. The use of such complex instruments may result in greater fluctuations of the value of the Master. The Manager of the Master, however, will ensure that the use of derivatives within the Master does not materially alter the overall risk profile of the Master.
- The Master may invest in private and unlisted equities which may involve additional risks such as lack of liquidity and concentrated ownership. These investments may result in greater fluctuation of the value of the Master and the Fund. The Manager, however, will ensure that any investments in private and unlisted equities do not materially alter the overall risk of the profile of the Master and the Fund.
- As this Fund is invested in a particular geographical region, you should be prepared to accept greater fluctuations in the value of the Fund than for a fund with a broader geographical investment mandate.
- Return on your investment may be adversely affected by variations in exchange rates.

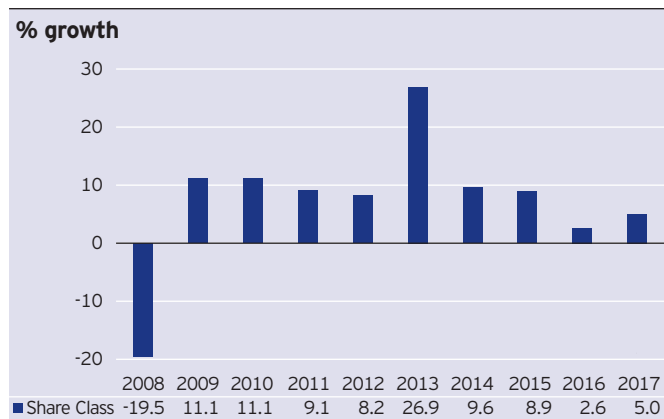
Charges
