# **Purpose**

# What is this product?

# Туре

The Umbrella Fund is established under the laws of Luxembourg and harmonised under the EU Council Directive 2009/65/EC relating to Undertakings for Collective Investment in Transferable Securities (UCITS).

### Term

The Fund does not have a maturity date and may only be terminated in accordance with the terms set out in the Prospectus.

### **Objectives**

- The objective of the Fund is to provide a positive total return over a market cycle with a moderate correlation to traditional emerging market debt indices.

- The Fund intends to gain exposure primarily to emerging market debt instruments (including convertibles) and currencies.

- The Fund will apply a risk management overlay in an effort to reduce risk.

- The Fund intends to gain exposure to commodities (excluding agricultural commodities) in an effort to reduce risk from exposure to currencies and emerging market debt instruments.

- The Fund intends to gain exposure to non-investment grade (lower quality) debt instruments, including debt instruments which are in financial distress (distressed securities).

- Depending on market conditions, the Fund may be invested up to 100% of its net asset value in money market instruments.

- The Fund may use securities lending for efficient portfolio management purposes.

- The Fund may make significant use of derivatives (complex instruments) in order to (i) reduce the risk and/or generate additional capital or income and/or (ii) meet the Fund's investment objectives by generating varying amounts of leverage (i.e. where the Fund gains market exposure in excess of the net asset value of the Fund).

- The Fund is actively managed and is not constrained by its benchmark, the 3 Month US T-Bills Index, which is used for comparison purposes. As the benchmark is a proxy for a money market rate, the overlap is not applicable.

- The Fund promotes environmental, social and governance (ESG) criteria as covered under Article 8 of the Regulation (EU) 2019/2088 on sustainability-related

The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the PRIIPs manufacturer to pay you.

#### **Performance Scenarios**

# What happens if IMSA is unable to pay out?

The assets of the Fund are segregated from those of IMSA. The Depositary is responsible for the safekeeping of the assets of the Fund. To that effect, if IMSA defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk for the Fund suffering some loss in case of default of the Depositary. As a shareholder in the Fund, there is no compensation or guarantee scheme in place.

If you sell some or all of your investment before 5 years the Fund will be less likely to achieve its objectives, however, you will not incur any additional costs by doing so.
