The rationale for these non-Dealing Days, is that the relevant local stock exchanges and/or Regulated Markets are closed. Since this will prevent investment teams from investing or disinvesting client flows, continuing to accept subscriptions, redemptions or switches may not be in the best interests of the Fund or its shareholders. For certain Funds that invest via Asian stock exchanges, the Business Day preceding an exchange closure may also be a non-Dealing Day.
