

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Name of Product: Invesco Sustainable China Bond Fund (the "Fund"), a sub-fund of Invesco Funds (the "Umbrella Fund"), Class A - monthly distribution -1 - HKD, (the "Share Class")

IMSA and the Fund are regulated by the Commission de Surveillance du Secteur Financier (CSSF) in Luxembourg. The CSSF is responsible for supervising IMSA in relation to this Key Information Document ("KID").

This KID is accurate as at 15 November 2024.

What is this product?

Type

The Umbrella Fund is established under the laws of Luxembourg and harmonised under the EU Council Directive 2009/65/EC relating to Undertakings for Collective Investment in Transferable Securities (UCITS).

Term

The Fund does not have a maturity date and may only be terminated in accordance with the terms set out in the Prospectus.

Objectives

- The objective of the Fund is to generate income and long-term capital growth, while maintaining a lower carbon intensity than that of the Fund's benchmark, while also integrating other environmental, social and governance (ESG) characteristics more fully described below.

- The Fund will invest primarily in Chinese debt instruments issued by companies or Chinese governments (including urban investment bonds as defined below) which meet the Fund's environmental, social and governance (ESG) criteria, as further detailed below.

- Urban investment bonds are debt instruments issued by Mainland China local government financing vehicles, which are separate legal entities established by local governments and/or their affiliates to raise financing for public welfare investment or infrastructure projects.

- The Fund may use securities lending for efficient portfolio management purposes.

- The Fund may invest in debt instruments which are in financial distress (distressed securities).

- The Fund may invest in non-investment grade (lower quality) or unrated debt instruments.

- The Fund will access China onshore bonds in the CIBM via Bond Connect and/or Qualified Foreign Investor (QFI).

- Screening is employed to exclude issuers that do not meet the ESG Fund's criteria, including, but not limited to, the level of involvement in certain activities such as coal, fossil fuels, tobacco, adult entertainment, gambling, and weapons.

- Positive screening is also used, based on the investment manager's proprietary rating system, to identify issuers with sufficient practice and standards or on an improving trajectory in terms of ESG and sustainable development for inclusion in the Fund's universe, as measured by their ratings relative to their peers.

- The investment manager monitors the carbon emission intensity of the portfolio to maintain a lower carbon intensity than that of its benchmark.

- The Fund may invest in contingent convertibles.

- The Fund may make significant use of derivatives (complex instruments) in order to (i) reduce the risk and/or generate additional capital or income and/or (ii) meet the Fund's investment objectives by generating varying amounts of leverage (i.e. where the Fund gains market exposure in excess of the net asset value of the Fund).

- The Fund is actively managed and is not constrained by its benchmark, the JP Morgan Asia Credit China and Hong Kong Index (Total Return), which is used for comparison purposes. While the benchmark is not consistent with the ESG

characteristics of the Fund, it is a suitable proxy for the wider investment universe and therefore it is likely that the majority of the issuers in the Fund are also components of the composite benchmark.

- The Fund has broad discretion over portfolio construction and therefore it is expected that over time the risk return characteristics of the Fund may diverge materially to the benchmark.

- The Fund promotes environmental, social and governance (ESG) criteria as covered under Article 8 of the Regulation (EU) 2019/2088 on sustainability related disclosures in the financial services sector.

- You can buy and sell shares in the Fund on any Dealing Day (as defined in the Prospectus).

- Any income from your investment will be paid monthly.

- The Share class may distribute out of gross income and/or directly from capital, therefore this may result in a reduction of the capital and may constrain future capital growth.

Intended Retail Investor

The Fund is intended for investors aiming for income and long term capital growth. The Fund is intended for investors who may not have specific financial expertise but are able to make an informed investment decision based on this document and the Prospectus, and have a risk appetite consistent with the risk indicator displayed below and understand that there is no capital guarantee or protection (100% of capital is at risk).

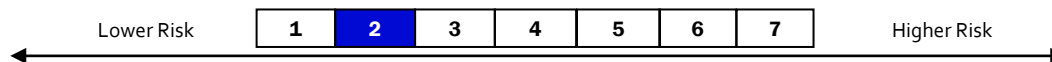

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the PRIIPs manufacturer to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency from your local currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Other risks such as Liquidity, Distressed Securities, Contingent Convertibles, Bond Connect, QFI, ESG and Derivatives risks may impact the Fund. Please refer to the Prospectus for more details.

Performance Scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product and a suitable benchmark over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

The unfavourable scenario occurred for an investment in the product/its proxy between August 2021 and September 2024.

The moderate scenario occurred for an investment in the proxy between March 2017 and March 2022.

The favourable scenario occurred for an investment in the proxy between August 2015 and August 2020.

What happens if IMSA is unable to pay out?

The assets of the Fund are segregated from those of IMSA. The Depositary is responsible for the safekeeping of the assets of the Fund. To that effect, if IMSA defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk for the Fund suffering some loss in case of default of the Depositary. As a shareholder in the Fund, there is no compensation or guarantee scheme in place.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

- HKD 100,000 is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

We have selected 5 years as the Fund invests for the long term.

You can sell your shares in the Fund on any Dealing Day as defined in the Prospectus.

If you sell some or all of your investment before 5 years the Fund will be less likely to achieve its objectives, however, you will not incur any additional costs by doing so.
