This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Name of Product: Invesco Net Zero Global Investment Grade Corporate Bond Fund (the "Fund"), a sub-fund of Invesco Funds (the "Umbrella Fund"), Class Z (EUR hedged) accumulation - EUR, (the "Share Class")

IMSA and the Fund are regulated by the Commission de Surveillance du Secteur Financier (CSSF) in Luxembourg. The CSSF is responsible for supervising IMSA in relation to this Key Information Document ("KID").

This KID is accurate as at 3 March 2025.

What is this product?

Type

The Umbrella Fund is established under the laws of Luxembourg and harmonised under the EU Council Directive 2009/65/EC relating to Undertakings for Collective Investment in Transferable Securities (UCITS).

Term

The Fund does not have a maturity date and may only be terminated in accordance with the terms set out in the Prospectus.

Objectives

- The Fund aims to contribute to the goal of achieving global net zero greenhouse gas emissions by 2050 or sooner. As part of achieving its objective the Fund intends to deliver income together with long-term capital growth.

- The Fund invests primarily in high quality debt instruments issued by companies worldwide, which in the view of the investment manager, are in line with the requirements of a Net Zero investment strategy and meet the Fund's environmental, social and governance (ESG) criteria.

- A Net Zero strategy is a strategy that focuses on achieving alignment objectives to:

- Decarbonise investment portfolios in a way that is consistent with achieving global net zero greenhouse gas (GHG) emissions by 2050.

- Increase investment in the range of 'climate solutions' needed to meet that goal.

- To meet the Net Zero goal, the Fund applies multi-faceted approach. The Fund will manage the reduction of the portfolio greenhouse gas emissions over the long term. This means that the Fund will invest in issuers that are already aligned to the decarbonisation pathway, as well as issuers which are on their way to alignment.

- The Fund selects issuers which are making consistent progress on aligning their business models to Net Zero.

- Screening is employed to exclude companies and/or issuers that do not meet the Fund's criteria on a range of other environmental and social metrics and the level of involvement in activities such as unconventional oil and gas.

- The Fund may invest in contingent convertibles.

- The Fund may make significant use of derivatives (complex instruments) in order to (i) reduce the risk and/or generate additional capital or income and/or (ii) meet the Fund's investment objectives by generating varying amounts of leverage (i.e. where the Fund gains market exposure in excess of the net asset value of the Fund).

- The Fund is actively managed and is not constrained by its benchmark, the ICE Global Corporate Climate Transition Absolute Emissions Index USD-Hedged (Total Return), which is used for comparison purposes.

- While the benchmark is not consistent with the ESG characteristics of the Fund, it is a suitable proxy for the wider investment universe and therefore it is likely that some of the issuers in the Fund are also components of the benchmark.

- The Fund has broad discretion over portfolio construction and therefore securities, weightings and risk characteristics will differ. As a result, it is expected that over time the risk return characteristics of the Fund may diverge materially to the benchmark.

- The Fund has a sustainable investment as its objective as covered under Article 9 of the Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector.

- You can buy and sell shares in the Fund on any Dealing Day (as defined in the Prospectus).

- Any income from your investment will be reinvested.

Intended Retail Investor

The Fund is intended for investors aiming to contribute to the goal of achieving global net zero greenhouse gas emissions by 2050 or sooner. The Fund is intended for investors who may not have specific financial expertise but are able to make an informed investment decision based on this document and the Prospectus, and have a risk appetite consistent with the risk indicator displayed below and understand that there is no capital guarantee or protection (100% of capital is at risk).

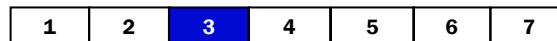

The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the PRIIPs manufacturer to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency from your local currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Other risks such as Liquidity, Contingent Convertibles, Bond Connect, ESG and Derivatives risks may impact the Fund. Please refer to the Prospectus for more details.

Performance Scenarios

What happens if IMSA is unable to pay out?

The assets of the Fund are segregated from those of IMSA. The Depositary is responsible for the safekeeping of the assets of the Fund. To that effect, if IMSA defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk for the Fund suffering some loss in case of default of the Depositary. As a shareholder in the Fund, there is no compensation or guarantee scheme in place.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

We have selected 5 years as the Fund invests for the long term.

You can sell your shares in the Fund on any Dealing Day as defined in the Prospectus.

If you sell some or all of your investment before 5 years the Fund will be less likely to achieve its objectives, however, you will not incur any additional costs by doing so.
